- To give children and young people an opportunity to contribute positively to their local community.
- To carry out special projects in partnership with other community groups, organisations and institutions to extend our reach and deepen our impact.
- To educate young people about the health and safety aspects of each discipline, teach them how to manage risk and engender a sense of responsibility for themselves and the groups safety.

As can be seen from the number and range of activities outlined in this report, this ambition was more than realised in 2024. The numerous workshops and outreach programmes, offered opportunities for local children and aspiring performers to learn from our skilled artists. These initiatives not only fostered local



talent but also strengthened our connections with the communities we serve. The highlight of the year, for many, was Solas Spectacular, a community spectacle of light. Hundreds of local residents, many of whom had participated in the making of the lanterns, paraded through the streets of Cloughjordan to the performance on the Village Green. As board members we were all proud to be associated with such a beautiful and high-quality event, knowing that the whole community had the opportunity to participate in such an inclusive, magical event.

2024 saw a change of Board members. A fond farewell and huge thanks to Martin Maguire, our previous Chairperson who oversaw the considerable consolidation of our governance structure and policies as well as contributing in so many other ways.

As always, I would like to acknowledge the financial support of the Arts Council, Tipperary CoCo and Creative Ireland. I would like to thank our partners in the community for their continued support and co-operation. Their contributions have been invaluable in enabling us to reach new heights and to continue to expand and to raise the standards which we aspire to.

As we look forward to 2025, we are excited about the new opportunities and challenges that lie ahead. We will continue to innovate, create and inspire, bringing the magic of the circus to a diverse group of people.

## ARTISTIC DIRECTOR STATEMENT

2024 feels like it has been our most ambitious to date. We have consolidated and interwoven the many strands of work that we have been developing for the past five years. Our small team is growing and in September we were delighted create a salaried position for Lead Circus Artist, Peter Moran.

We are also proud to continue to support and develop our home grown team. Circus Artist, Molly O'Brien is now a fully fledged and central member to our team. Marketa Sandes and Richard Sandes originally participants in our Wire programme have taken part in specialist training with the team to develop their skills in Funambulism (Wire Walking) and Facilitation.

This year was all about community for us. Our biggest ever annual performance project presented in December of this year was the culmination of a year long programme of engagement. 485 participants from local schools, local residents and families who took part in a whole range of creative opportunities including puppetry, lantern making, wire walking and circus programmes all of which came together to create this community spectacle of light, Solas Spectacular.

Our outreach programme is now a fully embedded part of our annual programme and this year ran year round with a different partner organisation in each term.



Outreach Partners in 2024 included First Steps, our local community creche, the A Team Youth Group from Nenagh and Meitheal 21 in Thurles.

Our collaborations with the wider Youth Circus community nationally have been allowed to flourish through the Circus Explored/Shared Island initiative led by the ISACS Network. The seventh Irish Youth Circus Gathering was able to go ahead thanks to support from this programme for the first time. IYCG 2024 brought together 19 young people from all over the island of Ireland. They met and created an amazing performance in just 2 days which was thoroughly enjoyed by the local community. Circus Explored also supported our Cruinniú na nÓg Programme and the outreach project with Meitheal 21.

I'd like to thank our board for their continued hard work and attention to detail behind the scenes and particularly Fiona Nolan who has taken on the role of Chair. In her role as staff liason, Fiona has also supported the organisation and me personally, to manage and support our growing staff team in a caring and professional manner. I'd also like to acknowledge our appreciation of the Arts Council, Tipperary Co Co Arts Office and Creative Ireland for their continuing support and advocacy on our behalf.

# SOLAS SPECTACULAR FEATURED PROJECT

Solas Spectacular presented a magical journey in light marking the transition from Autumn to Winter. A beautiful lantern procession led the audience to the village green where they were treated to a wonderous spectacle in circus and light evoking a visual and sensory transition from the warmth of autumn to the chill of winter.

The event itself was the culmination of a 9 month programme of community engagement in circus, funambulism, puppet making and lantern making. We began working on this ambitious project in the spring when we introduced our first public wire walking classes of the year and immersed our team in training with the European Centre of Funambulism. Following this the artistic team came together to begin to imagine how our community celebration of light might transpire.

The theme of transitioning from Autumn to Winter emerged and a further programme of community engagement commenced with a week long summer camp facilitated by Guest Artist Caoimhe Dunn to make our Giant Autumn Puppet followed by a programme of lantern making workshops involving 376 schoolchildren as well as 38 public participants.

Our Youth Circus members, 36 in all, played and created with specially sourced LED circus equipment, and the stilt group attended additional practices during the week. We even roped in a group of young adults - some local to Cloughjordan and others who are part of a group of international volunteers from the Cloughjordan Community Farm - to manipulate our beautiful seasonal windsocks on the night.



# SOLAS SPECTACULAR FEATURED PROJECT

On a windy Saturday evening in December (almost disrupted by Storm Darragh) our Autumn Puppet, accompanied by the lively beats of Bloco Garman, led a procession of over 150 lanterns made by our local community. On arrival at the green energetic scenes of windsock leaves falling and ribbons twirling amongst flurries of hula hoopers depicted autumn. This was followed by wintery scenes brought to life by icy stilt walkers, jugglers and winter windsocks to accompany the delicate beauty of wire walkers as they traversed the green on moving wires of light.

An amazing team of Artists led by Artistic Director Joanna Williams contributed to the final spectacle performance. Original Music was composed by Samuel Warmington, a former member of the youth circus. Costumes and windsocks were designed and made by Eileen Flanaghan and Joanna Williams. Sebastian Pizzaro collaborated to bring dynamic LED Lighting to the wire walking which was ably facilitated by Molly O'Brien with Richard and Marketa Sandes, and Peter Moran. Molly O'Brien and Joanna Williams worked with the youth circus members to create and devise the spectacle performances along with contributions from Dance Artist, Julie Lockett in direction of the windsock pieces.





JANUARY 2024

Weekly Youth Circus Programme

Weekly programme returns. In January 2024 we have 38 members across our 3 workshops, Beginner, Junior and Teens.

MARCH 2024

A Team Outreach The aim of this project was to enable participants to gain confidence and opportunities for social interaction. The project culminates in playing of favourite games, a big group pyramid and time for the young people to reflect on their experiences. One member requests to join our regular Youth Circus group.

**APRIL 2024** 

Circus Explored A partnership with 5 other youth circus groups, north and south, led by ISACS Network gets underway to promote and share circus nationally. This year there's planning for more exchanges, additional outreach programmes as well as events for Cruinniú na nÓg.

Wire Walking CPD & Public Workshops

Bruno Frenette visits from the European Centre of Funambulism to work with our tutor team to develop their facilitation skills. Following 2 days training he mentors the team over a weekend of public workshops.

MAY 2024

First Steps Early Years Circus In May we conclude a 7 week programme of workshops for our local community creche. The team put time into developing their understanding of early years and creating sessions that are fun, accessible and support the children's development.

Wire Walking

Weekly public workshops for wire walkers are every Wednesday in the summer term. There are sessions for children and for adults.



JUNE 2024

Weekly Youth Circus Programme Our weekly programme wraps up mid June with a performance of Beach Barage by Those Two Idiots. We also say goodbye to a number of our Teen members as they turn 18 or leave us to focus on exams and other interests. It's a privilege to have known many of them since they joined us at age 8 years old and to have had many fun experiences together.

Cruinniú na nÓg, Circus Explored

The culmination of our Circus Explored Programme we celebrate circus with a fun family day including family pyramid building, family wire walking sessions and a performance of Café aux Naux by Peter Moran.

Explorer Workshops, Circus Explored

In June we delivered 2 taster workshop days, one in a local school and 1 for a youth programme in the county.

CPD: Training Videos Paul Quate comes to help us produce a series of circus skills videos to serve as a teaching resource for new tutors, and as a refresher with tips and tricks for existing tutors to be more effective in the workshops.

JULY 2024

Summer Camps Summer Programme includes a week long summer camp for 26 participants. This year the camp is facilitated by 5 circus artists, 3 of whom are former members of our youth circus.

Summer Outreach Over the summer we also offered taster workshops to a number youth programmes in the county.

Puppet Camp Facilitated by Artist Caoimhe Dunn, a group of teens some from the A Team and some from our Youth Circus met for a week to make the giant puppet that would be part of our Annual Performance Project.

Wire Walking Training CPD

Our 4 tutors who lead the wire walking programme take part in a week long training at the European Centre of Funambulism, Brussels.

AUGUST 2024

Birr Vintage Parade Our puppet camp group take our giant puppet on its first outing as part of the Birr Vintage Week Festival.



SEPTEMBER 2024

Lead Circus Tutor

We officially welcome Peter Moran as a permanent member of our team.

Weekly Workshop Programme This term we welcome a new group of 16 beginners, bringing our total membership to 42 members. Workshops focus on skill development and creativity. Groups also begin working on ideas for Solas Spectacular.

Circus Explored, CPD Training

Circus Artist Peter Moran attends this inclusivity training with circus company Extraordinary Bodies hosted by Galway Community Circus.

Wire Walking Rehearsals

A group of 10 take part in the weekly practices working towards our Circus and Light Spectacle, Solas Spectacular.

Stilt Walking Rehearsals

Stilt Walkers meet weekly for additional practices as they work towards the Christmas Spectacle.

OCTOBER Annual Performance

LED Circus equipment arrives and rehearsals begin in earnest with all the youth circus groups. Costumes and Windsocks are designed and a group of young adults create movement pieces with the windsocks. We investigate how the LED lights can work on the tightwires.

Lantern Making Workshops

Our schools and public lantern making workshops begin with artist Caoimhe Dunn, preparing for Solas Spectacular.

Irish Youth Circus Gathering A smaller festival than usual, this time young people meet to create a perform an amazing show in the space of 1 weekend. This year included 4 partner youth circus organisations from North and South, Rural and Urban Irish Youth Circus Groups. Alongside the gathering we ran a 3 day outreach programme to bring a youth circus experience to local schools. This years gathering was part of Circus Explored, Wayfarer Exchanges.

Explorer Workshops, Circus Explored

This outreach programme runs for 8 weeks. Participants are a mixed age group and members of Meitheal 21, Down Syndrome Tipperary. This was a first outing for our new Sticklings accessible tightwire. We're looking forward to continuing to work with Meitheal21 in 2025.



NOVEMBER 2024

CARAVAN General Assembly CARAVAN is an international network of European youth and social circus projects. Circus Tutor, Molly O'Brien attended the CARAVAN General Assembly in Barcelona. Molly also participated in 2 days planning and ideas with the CARAVAN WAY Group

DECEMBER 2024

Annual Performance, Solas Spectacular

Our circus and light spectacle is part of the annual Christmas Lights Switch-On in Cloughjordan. It is a huge success with over 488 participants and an audience of over 700.

#### **INCLUSION**

My daughter is on the autism spectrum. She finds it difficult to mix. She was under no pressure doing this, unlike with sporting activities. She enjoyed going in everyday and telling us about the unicycle, tightrope etc. Parent, Summer camp

The benefits of this event for my child include talking and listening to other people and realising that you don't have to conform to certain criteria. Accepting each other's differences or 'weirdness' is vital in today's society and these exchanges or gatherings play an important role in that. It is hard growing up with social media and the need for perfection. These sessions allow everyone to be themselves, it is totally different to school and home life, the expectations are different; as a result they are more relaxed, less hindered by what society states is the 'norm'. Dare I say any 'weirdness' anyone might have is accepted. The teenagers are all readily accepted for who they are, what they want to do and what they want to learn. They do not feel pressurised. The leaders of Cloughjordan Circus Club are of a standard beyond anything I have ever experienced. Their training, skill and expertise and ability to instil self-belief in the children is something I have not experienced in extra-curricular activities before.

My children who are often challenged by competition and have experienced bullying and name calling due to a lower skill set has often led to feelings of inadequacy and self doubt however this class has inspired my kids to believe in themselves. Which is something we have really struggled with in the past.





for the financial year ended 31 December 2024

#### 1. General Information

Cloughjordan Circus Club Company Limited by Guarantee is a company limited by guarantee incorporated and registered in Ireland. The registered number of the company is 645539. The registered office of the company is The Crescent, Cloughjordan, Co. Tipperary which is also the principal place of business of the company. The nature of the company's operations and its principal activities are set out in the Directors' Report. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

#### 2. Summary of Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

#### Statement of compliance

The financial statements of the company for the financial year ended 31 December 2024 have been prepared on the going concern basis and in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" (FRS 102).

#### Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention except for certain properties and financial instruments that are measured at revalued amounts or fair values, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" issued by the Financial Reporting Council.

The company qualifies as a medium company as defined by section 280F of the Companies Act 2014 in respect of the financial year.

#### Income

Income

Income is recognised by inclusion in the Statement of Financial Activities only when the charity is legally entitled to the income, performance conditions attached to the item(s) of income have been met, the amounts involved can be measured with sufficient reliability and it is probable that the income will be received by the charity.

#### Income from charitable activities

Income from charitable activities include income earned from the supply of services under contractual arrangements and from performance related grants which have conditions that specify the provision of particular services to be provided by the charity. Income from government and other co-funders is recognised when the charity is legally entitled to the income because it is fulfilling the conditions contained in the related funding agreements. Where a grant is received in advance, its recognition is deferred and included in creditors. Where entitlement occurs before income is received, it is accrued in debtors.

Grants from governments and other co-funders typically include one of the following types of conditions:

- Performance based conditions: whereby the charity is contractually entitled to funding only to the extent that the core objectives of the grant agreement are achieved. Where the charity is meeting the core objectives of a grant agreement, it recognises the related expenditure, to the extent that it is reimbursable by the donor, as income.
- -Time based conditions: whereby the charity is contractually entitled to funding on the condition that it is utilised in a particular period. In these cases the charity recognises the income to the extent it is utilised within the period specified in the agreement.

In the absence of such conditions, assuming that receipt is probable and the amount can be reliably measured, grant income is recognised once the charity is notified of entitlement.

Grants received towards capital expenditure are credited to the Statement of Financial Activities when received or receivable, whichever is earlier.

#### Significant Judgements and Uncertainties

The Directors consider the below to be critical accounting estimates and judgements.

#### Going concern

The Directors have prepared budgets for a period of 12 months from the date of these financial statements, which demonstrates that there is no material uncertainty regarding the charity's ability to meet its obligations as they fall due.

#### Trade and other debtors

Trade and other debtors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method less impairment losses for bad and doubtful debts except where the effect of discounting would be immaterial. In such cases the receivables are stated at cost less impairment losses for bad and doubtful debts.

#### Trade and other creditors

Trade and other creditors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest rate method, unless the effect of discounting would be immaterial, in which case they are stated at cost.

#### Taxation

The company, as a registered charity, is exempt from taxation.

### 3. Departure from Companies Act 2014 Presentation

The directors have elected to present an Income and Expenditure Account instead of a Profit and Loss Account in these financial statements as this company is a not-for-profit entity.

#### 4. Income

Income includes government grant income, income from partnerships, sales income and donations.

The whole of the company's income is attributable to its market in the Republic of Ireland and is derived from the principal activity.
